SOUTHWEST MINNESOTA STATE UNIVERSITY

POLICY

ADMISSION

Southwest Minnesota State University is very interested in attracting and admitting students who provide evidence of strong academic preparation and of potential to be successful in the academic programs offered by the University. Potential academic success will be judged based on the applicant's past academic achievement (grade point average and class rank) and Nationally Standardized Test Scores (ACT or SAT). The University is committed to a policy that all persons shall have equal opportunity to our programs without discrimination on the basis of race, religion, sex, national origin, sexual orientation, or disability.

Freshman Admission Procedures

Freshmen are defined as students who have or will graduate from high school or who have attained the GED and who have not attended a post-secondary institution. Students who have earned college credit as a PSEO student are considered freshmen in the admission process.

I. Application for Freshman Admission

Students wishing to be considered for admission to Southwest Minnesota State University must present the following information:

- Completed application for admission and a non-refundable application fee of \$20.
- Official high school transcripts(s) or GED certificate.
- Scores from the ACT or SAT.

Note: Final high school transcripts, complete with date of graduation, must be submitted to the Office of Admission prior to enrollment.

II. Freshman Admission Criteria

Freshman admission may be granted to applicants entering directly from high school who meet the following criteria:

- Rank in the upper one half of their graduating class
OR
- Have attained a Composite Score of 21 on the ACT or 990 on the SAT

AND

- Have completed the following preparation requirements:
 - 4 years of English (includes composition, literature and speech)
 - 3 years of Math including 2 years of algebra and 1 year of Geometry
 - 3 years of Science. At least one course shall be in biological science and one in physical science. All courses should include lab experiences.
 - 3 years of Social Science including one year of US history and one in geography
 - 2 years of a single foreign language (including non-English native languages or American Sign Language)
 - 1 year of specified elective chosen from the following: World Culture or the Arts

The University will evaluate each applicant's credentials individually and note any deficiencies. If required college preparation courses are not offered at the student's high school, exemptions may be granted for admission purposes.

Students failing to meet the above class rank, ACT, or preparation requirements may still be considered for Provisional Admission but should contact the Southwest Minnesota State University Office of Admission for further details and criteria.

Provisional Admission

Students who rank in the upper 60% of their graduating class and have a minimum ACT Composite Score of 16 are eligible for Provisional Admission. Such students will be, in most cases, invited to campus for an interview with the Director of Enrollment Services. During this interview the student's past academic record and future plans will be discussed. Should the student be admitted, the following conditions will be placed on their enrollment:

- First term enrollment limit of 16 credits
- Must take College Study Skills during the first term of enrollment
- Must be advised by Learning Resources staff

Provisional Admission is not guaranteed.

Admission of Home School Students

Southwest Minnesota State University recognizes that not all students come to the University from the traditional high school setting. Therefore, students graduating from a Home School are required to meet the following criteria:

- Have attained a Composite Score of 21 on the ACT or 990 on the SAT
- Provide documentation of approved curriculum

Applicants are expected to document admission eligibility; those who are unable to present traditional documentation of educational preparation shall be individually evaluated on the basis of guidelines consistent with the institution's identity and mission.

Admission of GED Students

Students with an earned GED may be considered for admission after submitting the following:

- Official copy of the GED Certificate
- Official high school transcripts
- ACT or SAT scores (if under the age of 21)

Transfer Student Admission Procedures

Students who have acquired credits from another post-secondary institution are considered transfer students and should follow the guidelines below:

I. Application for Transfer Admission

Transfer students wishing to be considered for admission to Southwest Minnesota State University must present the following information:

- Completed application for admission and non-refundable application fee of \$20.
- Official transcripts from **each** post-secondary institution attended. Transcripts must be sent directly from each institution to the Southwest Minnesota State University Office of Admission.

II. Transfer Admission Criteria

Transfer admission may be granted to students who meet the following criteria:

- Have attained a minimum grade point average of 2.00 (on a 4.00 scale) in previous college coursework from a college, university, or technical college.
- Students wishing to transfer with fewer than 24 semester hours from an accredited two or four institution must submit an official high school transcript.

Information regarding preparation for transfer or evaluation of transfer credits may be obtained by contacting the Transfer Specialist in the Office of Admission.

Students who do not possess the above stated admission requirements may be considered for Provisional Admission if judged to have potential to be successful in the academic program at Southwest Minnesota State University.

Students who have been suspended from another institution will not be considered for admission to Southwest Minnesota State University until the suspension has been lifted by that institution or until one year has elapsed. Students possessing debts at other institutions will not be offered admission to the University.

International Student Admission

Readmission to the University

Students who have attended Southwest Minnesota State University in the past and have not been enrolled in the last one or more terms (excluding summer sessions) will be considered for readmission and should

contact the Office of Admission for more information and application materials. If a student has attended another college/university during his/her time away from Southwest, official transcripts from that institution are required. Students required to withdraw from Southwest Minnesota State University are not eligible for readmission for the equivalent of one academic year.

Enrollment of High School Students

Concurrent with high school enrollment, high school students may be admitted to Southwest Minnesota State University for either part-time or full-time enrollment under the Post Secondary Enrollment Program. Enrollment is dependent upon space availability in the courses desired by the students. Students wishing to enroll must meet the following requirements:

- High School Seniors must rank in the upper one-half of their graduating class while juniors must rank in the upper one-third.
- Submit the appropriate form (PSEO or SACP) signed by a designated school official and parent.
- Submit official transcript noting class rank.

Students planning to attend Southwest Minnesota State University under the PSEO program are strongly encouraged to work closely with their high school counselor. Questions relative to the PSEO program should be directed to the Southwest Minnesota State University Office of Admission.

Enrollment of Part-Time, Non-Degree Students

Southwest Minnesota State University recognizes that not all students can attend college full-time. For this reason, part-time, non-degree seeking students **who have not been enrolled in secondary school or another college/university for one year** may be allowed to enroll in a maximum of six credits per semester by completing a part-time student application. Students may continue under this status until they have earned 36 credit hours, at which time they must apply for admission and provide all documentation listed previously. Concurrently enrolled high school students may not enroll under this status. It is important to note that students under this status are often not eligible for financial aid.

Non-Traditional Student Enrollment

Students planning to attend Southwest Minnesota State University who are over the age of 21 with no previous post-secondary education may be admitted upon application and proof of high school graduation or equivalent (GED). Those students who have successfully completed the GED will be considered for admission upon evaluation of official GED scores. Although no ACT score will be required for admission, students should expect institutional assessment tests upon entrance to the University.

Senior Citizens

The 1975 Minnesota Law, Chapter 136, "Senior Citizens Higher Education Program," allows residents who have reached the age of 62 years or older prior to the beginning date of a course to enroll for credit. The administrative charge for senior citizens taking credit courses on a space available basis will be assessed. Senior citizens may audit credit courses at no charge and have all fees except laboratory and material fees waived.
