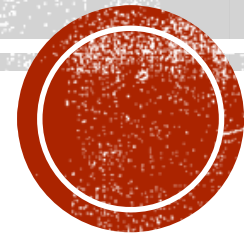

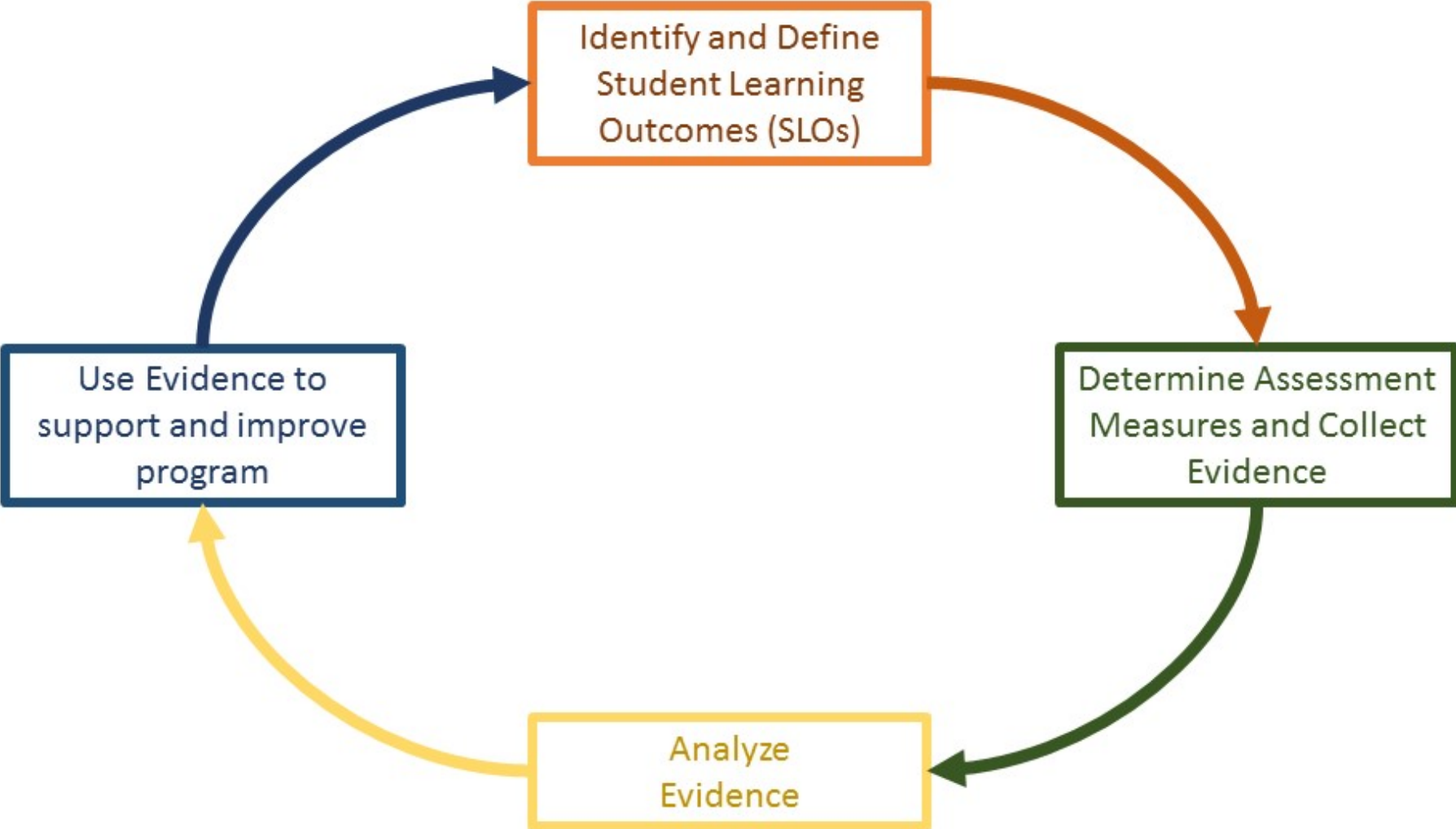

ASSESSMENT LEVEL 3 ACTIVITIES

From the Mini-Grant Application:

Level 3 focuses on providing a plan for analysis of collected data or evidence using previously defined assessment measures

- Activities related to Level 3 include
 - Review of assessment data
 - Analysis of collected data or evidence
 - Other analysis

ASSESSMENT LEVEL 4

From the Mini-Grant Application:

Level 4 focuses on providing a plan for using analyzed data or evidence to support sustained success or to implement practices for continuous improvement

- Activities can include
 - Curriculum redevelopment
 - Planning for implementation of new curriculum
 - Drafting cyclical program review
 - Drafting cyclical accreditation reports
