

## 2026-2027 Verification Worksheet

If the information you provide indicates that you, your parent, or your spouse (if married) were required to file a Federal Tax Return, processing of your financial aid application will stop until that individual file the appropriate return and submits either an IRS Tax Transcript or a signed copy of the Federal Tax Return.
