










### Are you aware that the City of Marshall has proposed the constructions of an Amateur Sports Complex?






# How familiar are you with the proposed Sports Complex proposal? (1 being not informed and 10 being very well informed)






# Are you aware that the City of Marshall has proposed a need for an expanded MERIT Center?






# How familiar are you with the MERIT Center expansion proposal? (1 being not informed and 10 being very informed)






### How involved are you and/or your family members with Marshall athletics?






## Which sports are you and/or your family members involved?




## In your opinion, how adequate are the current sports facilities in the Marshall area?






### I felt/feel that the city of Marshall needed/ needs more shopping, entertainment, and/ restaurants.






### My feelings concerning the proposed MERIT Center and Amateur Sports Complex are: (check all that apply)




#### Statements Regarding Benefits of the MERIT Center and Amateur Sports Complex- Summary of Means






### Respondent Age Related to Yes Vote


